

(Our League members wrote 3.000 postcards in 2024, but the program was set aside during the frenzy of the election.)

Wanda also goes to the local women's prison. She is developing a course about voting to offer to the inmates.

Cassie DeCoulette came up to introduce me to Sue Motley, a retired attorney. Both of them want to work with Wanda. Scott Baldwin wants to help, and so does Debbie Savarese.

That's how it happens. People connect with people, work together, and things get done. A little at a time. That is my goal for this League chapter. Involvement in these political issues will not only help the cause but will result in your meeting some terrific people and making good friends. It's up to you to decide to participate. If you don't you will never know what you missed.

From the League of Women Voters, Impact on Issues

Summary of Public Policy Positions *League of Women Voters* of the United States REPRESENTATIVE GOVERNMENT

Promote an open governmental system that is representative, accountable, and responsive.

Voting Rights

Citizen's Right to Vote. Protect the right of all citizens to vote; encourage all citizens to vote.

DC Self-Government and Full Voting Representation. Secure for the citizens of the District of Columbia the rights of self-government and full voting representation in both houses of Congress.

Election Process

Apportionment. Support apportionment of congressional districts and elected legislative bodies at all levels of government based substantially on population.

Redistricting. Support redistricting processes and enforceable standards that promote fair and effective representation at all levels of government with maximum opportunity for public participation.

Money in Politics. (formerly Campaign Finance) Support campaign finance/MIP regulations that enhance political equality for all citizens, ensure transparency, protect representative democracy from distortion by undisclosed contributions and big money, and combat corruption and undue influence in government. Support campaign spending that is restricted but not banned. Support public financing, full disclosure, abolishing super PACs, and creating an effective enforcement agency.

Selection of the President. Promote the election of the President and Vice-President by direct popular vote.

Support uniform national voting qualifications and procedures for presidential elections. Support efforts to provide voters with sufficient information about candidates.

Voter Representation/Electoral Systems. Support electoral systems at each level of government that encourage participation, are verifiable and auditable, and enhance representation for all voters.

Citizen Rights

Citizen's Right to Know/Public Participation. Protect the citizen's right to know and facilitate informed understanding and public participation in government decision-making.

Individual Liberties. Oppose major threats to basic constitutional rights.

Public Policy on Reproductive Choices. Protect the constitutional right of privacy of the individual to make reproductive choices.

Evaluating Constitutional Amendment Proposals and Constitutional Conventions

Amendment Proposals. Consider whether a proposal addresses matters of abiding importance, makes our political system more democratic, protects individual rights, could be achieved by a constitutional amendment or legislative proposal, and is consistent with other League positions.

Constitutional Conventions. Hold constitutional conventions only when certain conditions are in place, including limited to a specific topic, full transparency, delegates selected by population, and voting by delegates not by states.

Congress and the Presidency

Congress. Support responsive legislative processes characterized by accountability, representativeness, decisionmaking capability, effective performance, and transparency.

The Presidency. Promote a dynamic balance of power between the executive and legislative branches within the framework set by the Constitution.

Privatization

Ensure transparency, accountability, positive community impact, and preservation of the common good when considering the transfer of governmental services, assets, and/or functions to the private sector.

Digital Equity

High-speed affordable internet access is an essential service that should be readily available to all US residents and businesses.

RH&J: Where are we going next?

In the December 6 Lunch & December 7 Lunch & Decemb

- 1) keep reminding our lawmakers that 57% of their constituents rejected the current
- abortion ban,
- 2) require transparency about the consequences of the extreme ban—especially data
- on infant and maternal mortality,
- 3) oppose even worse bills,
- 4) continue to emphasize that reproductive choice is health care,
- 5) help women locally, and
- 6) address mis/disinformation about reproduction, particularly concerning the myriad,
- unpredictable complications of pregnancy (because these make the extreme ban so

cruel), and exactly how one can prevent pregnancy.

Let's start there. Regressive conservatives want voters and politicians to be confused about the difference between contraception methods and abortion methods. Crazy fact: not even physicians understand this!

From NPR's Morning Edition on December 16: "A recent survey published in a medical journal found that 17% of doctors from different specialties believe an IUD

causes abortion. In fact, IUDs prevent fertilization and conception in the first place."

It gets worse. "A group called Students for Life goes further, calling birth control pills,

IUDs, birth control implants and emergency contraception all abortifacients, saying only

condoms, diaphragms, vaginal sponges, spermicide and "natural family planning" are

acceptable forms of birth control." (USA Today, Oct. 22).

Memorize this!

- 1) Condoms and diaphragms prevent fertilization, as do IUDs.
- 2) Hormonal methods (birth control pills, morning-after pills, IUDs with hormone release, and hormonal rings, patches or injections) prevent ovulation.
- 3) We need to broadcast that Plan B pills (aka emergency contraception, morning-

after pills) are just ovulation-suppressing hormones. They work only if ovulation hasn't happened yet.

If you prevent ovulation or fertilization, then conception cannot happen and, therefore,

abortion cannot happen. Let us be informed and assertive in the community to increase

people's knowledge of these basic facts.

Adapting the Nature Coast to a Wet Future

A free community forum hosted by The Nature Coast Unitarian Universalists Fellowship 7633 North Florida Avenue Citrus Springs, FL 34434 (Dunnellon for GPS) Saturday, January 25, 2025, 3:00 PM-5:00 PM

The vulnerability of the Nature Coast to storm surge flooding has been highlighted by the recent impacts of Hurricanes Ian, Helene, and Milton. The US Global Change Research Program concludes that the severity and risks of coastal hazards are rapidly increasing. In this free community forum, we will begin with a review of some of the short-term and long-term strategies that can help promote resilience. Professor Gary Zarillo of Florida Institute of Technology (https://www.fit.edu/faculty-profiles/z/zarillo-gary/) will outline some of the mitigating approaches that can help residents stay safe and be resilient now and, in the decades, ahead. The key themes of this event will be Short Term Resilience and Post-storm Recovery and Long-term Adaptation to a Wet Future. Professor Zarillo's overview presentation will be directly followed by an open-forum discussion and Q&A session. During the discussion hour, Nature Coast residents, particularly those impacted by Hurricanes Helene and Milton, will have opportunities to briefly share their experiences and lessons learned. Professor Zarillo will orchestrate the discussion and take questions.

THE NONPROFIT FLORIDA SPRINGS COUNCIL SUED THE FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION (FDEP) RE: THE HARM RULE

There are 30 Outstanding Florida Springs (OFS). The Florida Springs Council (FSC) filed a lawsuit alleging that these springs have been harmed because the Florida Department of Environmental Protection (FDEP) has delayed in adopting a "harm rule." This rule was mandated by the State Legislature via a 2016 law (SB 552) ordering FDEP to adopt rules to better protect Outstanding Florida Springs against water withdrawals that reduce water flows and thereby harm springs. (Pollution makes it worse.)

Such a rule should define the meaning of "harmful" to prevent harmful groundwater withdrawals from OFS and spring runs. Meanwhile, the Water Management Districts have continued to issue water use permits, harming OFS. Read this great article covering the story to that point by WUFT, PBS, NPR:

UPDATE:

FDEP has finally released another draft of proposed "harm" rules: 62-41.400 - 62-41.403, on August 29, 2024, which will not adequately protect springs.

BMAPS (BASIN MANAGEMENT ACTION PLANS) MEETINGS FOR WEEKI WACHEE, CHASSAHOWITZKA, HOMOSASSA, AND CRYSTAL RIVER/KINGS BAY WERE HELD BY FDEP ON NOVEMBER 7TH IN HERNANDO COUNTY UPDATE:

The Springs and Aquifer Protection Act, which was passed in 2016, requires the Florida Department of Environmental Protection (FDEP) to develop Basin Management Action Plans (BMAPS), which are recovery plans for Florida's nitrate-impaired springs.

The Florida Springs Council sued the Florida Department of Environmental Protection in 2019 because it noticed gaps in the BMAPs. After four years, in 2023, the 1st District Court of Appeals ruled that FDEP must rewrite the BMAPs by July 2025.

As part of a state-wide effort, on November 7th in Brooksville, Hernando County, Florida, the FDEP hosted a public meeting, gave a presentation on the draft BMAPS for our local springs, Weeki Wachee, Chassahowitzka, Homosassa, and Crystal River/Kings Bay Basins. They put up posters with statistics and information, and invited participants to ask questions and make comments on cards which they supplied. Those comments were to be included in FDEP's final report of the meeting. **The final BMAPs will be reviewed at public hearings by January 2025.**

FLORIDA RIGHT TO CLEAN WATER CONSTITUTIONAL AMENDMENT FOR THE 2026 ELECTION – HOW TO VOLUNTEER AND GET INVOLVED

Florida Right To Clean Water.org is a grassroots, volunteer, nonpartisan organization formed to place an amendment to the <u>state constitution</u> on the November 3, 2026 ballot by citizens before the voters of the <u>U.S. state</u> of <u>Florida</u>, using a <u>direct initiative</u> petition that will give citizens of the state a right to clean and healthy waters. CITRUS COUNTY COMPREHENSIVE PLAN AMENDMENT APPLICATION NO. - CPA-2024-00005 ROBERT BATSEL, JR. for 1728 INVESTMENTS, LLC – REVISION TO CHAPTER 13 – MANATEE PROTECTION ELEMENT

This application would amend the objectives and policies associated with residential dock densities in the Manatee Protection Element of the Comprehensive Plan. This application was scheduled to have its final hearing before the Citrus County Board of County Commissioners at 5:05 pm on Tuesday, December 10, 2024, but this Item I. The 12/10 Public hearing to approve CPA-2024-00005 Comprehensive Plan Manatee Element Changes: was removed from the agenda. Instead, the applicant for the amendment has requested a 180-day extension for approval while trying to work out concerns with FWC and US Fish and Wildlife.

STATE LEGISLATION FILED TO DEFINE USES OF FLORIDA STATE PARKS AND WHAT WILL BE PROHIBITED

On December 4th, Florida State Senator Gayle Harrell filed legislation: Senate Bill 80: State Land Management; Citing this act as the "State Park Preservation Act." https://www.flsenate.gov/Session/Bill/2025/80 https://www.youtube.com/watch?v=9xECC7mo-G0

This bill was filed as a result of Florida Department of Environmental Protection's attempt to allow tennis courts, golf courses, and pickleball courts to be built on nine of the Florida State Parks. There was huge public outcry, demonstrations, and bipartisan opposition to this. Senator Harrell's bill is intended to define how to preserve and protect the natural habitat and endangered species in our state parks and to open it up to people to enjoy. Some things it would allow are horseback riding, bike paths, swimming and hiking. It would prevent tennis courts, golf courses, pickleball courts and ball fields from being built in Florida state parks for recreational use. The bill would also require a 30-day notice for any proposed changes to allow the public's voices to be heard.

According to the 2025 Acquisition and Restoration Council (ARC) calendar for 2025, the next meeting is scheduled for February 14, 2025, at the DEP in Tallahassee.

The item of the land swap deal has <u>not</u> been on the Acquisition and Restoration Council (ARC) agenda since the issue came up. It was not on the agenda for the December 12th and 13th meeting.

WITHLACOOCHEE STATE FOREST LAND GRAB OPPOSITION TO PROPOSED SWAP OF 324 ACRES OF CONSERVATION LANDS



Withlacoochee State Forest parcel earmarked for land swap

This past June, without any public input, nor any discussion on the part of its members, the Florida Governor and Cabinet voted to approve transfer of 324 acres of land within the Withlacoochee State Forest in Hernando County to Cabot Citrus OpCo LLC, a Canadian corporation, to expand its adjoining luxury golf course/resort development in exchange for 861 acres of pine plantation in Levy County. It had obtained approval earlier from the Hernando County Commission to build 1770 residential units and a large area of commercial development on the land it already owns adjacent to this part of the Withlacoochee State Forest.



Numerous letters of opposition have been sent to Rick Dolan, Director of the Florida Forest Service and his direct supervisor Wilton Simpson, Florida Secretary of Agriculture & Consumer Affairs including Sierra Club Florida Chapter's letter with 67 sign-ons from other organizations, Sierra Club Florida Chapter Conservation Committee's letter enclosing an expert assessment of the value of these conservation lands (Eval Withlacoochee State Forest Tract Being Considered in Land Swap), Sierra Club Adventure Coast Group's, one from Sonny Vergara - former Executive Director of SWFWMD, and letters from many other conservation organizations and individuals. We have all been stonewalled and no replies nor even acknowledgment has been received to our letters.

Adventure Coast Group noted our three major objections: The proposed land swap establishes a dangerous precedent for other public lands desired by developers. The Withlacoochee State Forest Parcel has considerable conservation value due to its contiguity with other public conservation lands and its role as a link in the Florida Wildlife Corridor. Value as a High Groundwater Recharge Area within the Chassahowitzka Springshed, a declared Outstanding Florida Spring.

The land swap is contingent upon review and approval by both the Florida Forest Service (FFS) and the Acquisition and Restoration Council (ARC). This item was not included in the agenda of their October meeting that was canceled due to weather, nor is it on the agenda for their November meeting.



This land swap is contrary to good public policy and Government in the Sunshine. It is contrary to the goal of Florida Forever—protecting lands with significant natural resource values in perpetuity for all Floridians. It undermines a long record of successful conservation of Florida's valuable lands that protect our environment, support our tourist-based economy, and provide clean water to support both nature and people. We hope that input from the conservation community will encourage state officials to end this ill-advised gift to private development interests. Stay tuned! When we learn more, we'll let you know.

HEAT ILLNESS AND LEGISLATION

During the 2024 Florida legislative session, Governor DeSantis signed a bill HB 433 Employment Regulations, that prevented local governments in Florida from requiring heat protection for outdoor workers. NPR pointed out that roughly two million people in Florida, from construction to agriculture, work outside as of Apr 15, 2024. Workers continue to suffer from heat illness and some have died from it.

OSHA (the federal Occupational Safety and Health Administration) has written and published a Rule on Heat Illness. The comment period has been extended until January 14, 2025. An informal public hearing on the proposed rule will be held virtually and begin on June 16, 2025. Get the facts and all the details and see what you can do here:
